I understand that CEF is without specific denominational affiliation, and have read the Statement of Faith and CEF Doctrinal Protection Policy. In becoming a coworker with CEF, and in order to protect the ministry, I agree not to propagate or practice in CEF ministries any distinctive or controversial doctrines, methods and practices that would go beyond the CEF Statement of Faith and the approved CEF curriculum. These would include but not be limited to such things as modes of baptism, speaking in tongues, interpretation of Scripture by experience, healing on demand, etc. I understand that anyone who does not adhere to this agreement cannot serve with CEF as paid staff or volunteer.

In teaching Bible lessons in core CEF programs I will use exclusively materials approved by CEF. ### Child Evangelism Fellowship® Statement of Faith

#### WE BELIEVE -

- That "All Scripture is given by inspiration of God," by which we understand the whole book called THE BIBLE; that it is inerrant in the original writing and that its teaching and authority are absolute, supreme and final. That the Holy Spirit guided the holy men of old in all that they wrote. 2 Timothy 3:16; Deuteronomy 4:2; 2 Peter 1:21
- The Godhead eternally exists in three persons, the Father, the Son and the Holy Spirit. These three are one God, having the same nature, attributes and perfection.

  Romans 1:20; Matthew 28:19; Deuteronomy 4:35; John 17:5
- In the personality and Deity of the Lord Jesus Christ, begotten of the Holy Spirit, born of the virgin Mary, truly God and truly man. John 1:1, 14; 10:30; Matthew 1:20; Luke 1:30,31; Philippians 2:5-7; 1 Timothy 3:16; Colossians 1:19
- In the personality and Deity of the Holy Spirit, the source and power of all acceptable worship and service, the infallible interpreter of the infallible Word, who indwells every true believer, and is ever present to testify of Christ, seeking to occupy us with Him and not with ourselves or our experiences. John 15:26; Acts 5:3-4; 1:8; Romans 8:26-27; 1 Corinthians 2:12,14; Romans 8:9; 1 Corinthians 3:16; 12:13; John 16:13-14
- That man was created in the image of God, after His likeness, as stated in the Word of God, but the whole human race fell in the fall of the first Adam. Not only was his moral nature grievously injured by the fall but he totally lost all spiritual life, becoming dead in trespasses and sins, and subject to the power of the devil. "The carnal mind is enmity against God; for it is not subject to the law of God, neither indeed can be. So then, they that are in the flesh cannot please God" (Romans 8:7,8). Therefore, he cannot see nor enter the kingdom of God until he is born again by the Holy Spirit. That no degree of reformation however great, no attainment in morality however high, no culture however attractive, no humanitarian and philanthropic schemes and societies however useful, no baptism or other ordinance however administered, can help the sinner to take even one step toward Heaven; but a new nature imparted from above, a new life implanted by the Holy Spirit through the Word is absolutely essential to salvation. - That Jesus Christ became the sinner's substitute before God, and died as a propitiatory sacrifice for the sins of the whole world. That He was made a curse for the sinner, dying for his sins according to the Scriptures; that no repentance, no feeling, no faith, no good resolutions, no sincere efforts, no submission to the rules and regulations of any church can add in the very least to the value of the precious blood or to the merit of that finished work wrought for us by Him, who tasted death for every man. 1 John 2:2; Hebrews 2:9; Galatians 3:13; Romans 3:25; 4:4-5; 5:8; Colossians 1:13-14,20-21
- In the resurrection of the crucified body of Jesus Christ; that His body was raised from the dead according to the Scriptures, and that He ascended into Heaven and sitteth on the right hand of God as the believer's high priest and advocate. Luke 24:39; Acts 1:10-11; Ephesians 4:10; Hebrews 1:3; 1 John 2:1

- That Christ in the fullness of the blessings He has secured by His death and resurrection is received by faith alone and that the moment we trust in Him as our Savior we pass out of death into everlasting life, justified from all things, accepted before the Father according to the measure of His acceptance, loved as He is loved and made one with Him. At the time of acceptance of Christ as Savior, He comes to dwell within the believer and to live out His life of holiness and power through him. Hebrews 9:15; John 5:24; Romans 3:28; 4:3,23-25; Ephesians 1:3; John 17:23; Galatians 2:20; 4:6-7; 5:16; Acts 1:8
- That the Church is composed of all those who truly believe on the Lord Jesus Christ as Savior. It is the body and bride of Christ. That every believer, whether Jew or Gentile, is baptized into the body of Christ by the Holy Spirit, and having thus become members of one another we are responsible to keep the unity of the Spirit in the bond of peace, rising above all sectarian prejudices and denominational bigotry and loving one another with a pure heart fervently. Ephesians 1:22-23; 2:19-22; 1 Corinthians 12:22-27; 1:10-13; Romans 12:4-5; Ephesians 4:3-6; 5:32; Philippians 2:1-5; Galatians 5:13-15
- That all believers in our Lord Jesus Christ are called into a life of separation from worldly and sinful practices, and should abstain from such amusements and habits as will cause others to stumble, or bring reproach upon the cross of Christ. Believers are created in Christ Jesus unto good works. "As we have therefore opportunity, let us do good unto all men, especially unto them who are of the household of faith" (Galatians 6:10). 1 John 2:15-16; Romans 13:14; 14:13; 1 Corinthians 10:31; Ephesians 2:10
- In the evangelization of the world, that the supreme mission of the people of God in this age is to preach the Gospel to every creature. That special emphasis should be placed upon the evangelization of children. Mark 16:15; 2 Corinthians 5:18-19; Matthew 18:14
- In the personal return of our Lord and Savior Jesus Christ, that the coming again of Jesus Christ is the "blessed hope" set before us, for which we should be constantly looking. ### Criminal record check

CEF policy requires that all workers and volunteers complete a criminal background check. Your CEF Local Chapter will provide the paperwork and procedures for our Background check. This must be completed and on file with the State Office prior to you attending CYIA training or working with children in a CEF ministry. If you are a returning student, we should have this on file unless your information has expired and needs to be rechecked.

#### **Code of Conduct**

Representing Jesus Christ as a CEF Summer Missionary

As *CYIA* students, we represent Jesus Christ while teaching kids about Him! As His representatives, we commit to the following.

#### We'll seek and honor God

- We will maintain active prayer and devotional lives. Daily quiet time with God is essential to our effectiveness, passion, and testimony in ministry.
- We will honor God with our bodies, both in the way we dress and in the way we treat our bodies.
  - *Clothing:* The way we present ourselves to children and others impacts our effectiveness at sharing the Gospel. We will dress modestly and in good taste. The following types of apparel are not acceptable:
    - "short shorts" (i.e. above mid-thigh)
    - clothing that reveal undergarments
    - leggings, unless worn with skirt or shorts
    - shirts that reveal midriff
    - spaghetti strap tops
    - anything bearing inappropriate advertisements or logos
  - Our bodies: The use of drugs and alcohol is strictly forbidden. If I struggle with any form of self-injury, I will seek immediate counsel and help from CEF staff and other trusted adults.

#### We'll respect other people

- We will be on time for all training classes, meals, duties, and activities.
- We will consider others when using electronic devices. We will not use electronic devices (such as iPods and phones) during training or 5-Day Clubs.
- We will remain above reproach in our relationships with others. In order to maintain high standards of Christian conduct, we will not meet alone with a person of the opposite gender unless we are in clear public view.
- We are responsible to our local *CEF* staff in regard to our work assignments and serving throughout the summer under their authority.

#### We'll strive to do our best

• In order to serve as a summer missionary, we must complete all assignments at training. You will be allowed to work as a summer missionary only after all assigned work is satisfactorily completed.

The CEF staff reserves the right to approach you on any of these issues, keeping in mind that the goal for this program is to equip you to effectively minister to children and to grow in your Christian faith. Misconduct and/or violations of these expectations may result in suspension from the CYIA program after proper counseling by the staff.

#### **Worker and Parental Agreement**

Weekly schedules will be emailed to you as soon as completed, often this will be on the weekend before the week itself. On occasion, a club will be changed for the day/week by those in charge of the location where a club is held. If this happens, drop off and pick up times and places may be affected.
